Stingray and Copyright

Stingray is considered to be a form of radio broadcaster for both regulatory and copyright purposes in Canada. As a result of this designation, Stingray is subject to a very similar copyright regime as over-the-air commercial radio broadcasters. Combined, Stingray's services generate over \$12 million dollars per year in rights and royalties payments to various rights holders and collective societies around the world. As such, Stingray also shares some of the same concerns as radio broadcasters in respect of the proliferation of tariffs and the resultant growth in liability for our services in Canada. From Stingray's perspective, this growth could impede its progress as a Canadian-based broadcaster and technology company exporting its services around the world.

Reproduction Right Exception

Stingray supports the amendments to section 30.9 being proposed by the Canadian Association of Broadcasters. Stingray considers the reproduction right exception for radio broadcasters to be an essential component of Bill C-11, subject to the removal of the 30-day destruction requirement in subsection 30.9(4).

Neighbouring Rights Reciprocal Treatment

Stingray respectfully requests that the Minister of Industry publish a statement in the Canada Gazette at the time Bill C-11 is enacted to state that no payments will flow to the countries that do not provide a right of similar scope and duration to their own nationals. The publication of this statement is contemplated in section 20.21 of Bill C-11 as a means to ensure fairness in national treatment.

Thank you for the opportunity to present the perspective of Stingray Digital on Bill C-11.
