1. Economic Recovery and Growth

To own a bottle depot in Alberta you need to get a Lincence to open one and yet to

open a Liquor store you don't need one. And to get a Licence from the Provincial Government for a bottle depot is \$3000 and to buy a running business the Licence goes to \$1,000,000. Minister Kenny, don't get me wrong. You and the government are doing a great job under the circumstances. Above are just some comments for more support on supply Management.
