Responses

1. Economic Recovery and Growth

Given the current climate of federal and global fiscal restraint, what specific federal measures do you feel are needed for a sustained economic recovery and enhanced economic growth in Canada?

Interest rates need to be maintained and gasoline oil prices need to be reduced according to oil pricing. I do not understand that the entire city of Windsor / Tecumseh can raise their prices on a given hour to the exact same price / liter and no one can associate this with "price fixing". Also we need a "hot line" to report abuse of disability insurance. 2. Job Creation

As Canadian companies face pressures resulting from such factors as uncertainty about the U.S. economic recovery, a sovereign debt crisis in Europe, and competition from a number of developed and developing countries, what specific federal actions do you believe should be taken to promote job creation in Canada, including that which occurs as a result of enhanced internal and international trade?
