1. Economic Recovery and Growth

Given the current climate of federal and global fiscal restraint, what specific federal measures do you feel are needed for a sustained economic recovery and enhanced economic growth in Canada?

Throughout his apprenticeship, he had to pay for every thing including \$1500 for school and upwards of \$1000 for books and then to make matters worse, he has to wait for unemployment insurance while he is in school. Understanding that apprenticeships are Provincial, make funding available from the Feds to pay for apprentices to make it more appealing.
