DISCUSSION QUESTIONS
<p>What did participants say about the current system for electing Members of Parliament (benefits/flaws)? Did participants feel that their votes are fairly translated? (suggested limit: 500 words)</p> <p>A Town Hall consultation was held in Richmond Hill in support of the national dialogue on electoral reform taking place across the country. Residents in the constituency were invited to join the dialogue on electoral reform, with each other and their local representative. Special guest, MP Mark Holland was also in attendance and engaged in the dialogue with MP Jowhari and local residents of his constituency. There was an engaged audience and many questions regarding the electoral process were directed at MP Holland. <u>Some comments:</u></p> <ul style="list-style-type: none"> • Canada's 150th birthday will provide a great opportunity to review bureaucratic system and amend the Elections Act. • Electoral Reform will address areas like online voting and voting internationally. • We need a consensus and by-partisan reflection of how it should work. • The majority government has given up authority on the Committee designate. • The 5 principles set out in the Motion to create electoral change are; Effectiveness & Legitimacy, Engagement, Accessibility & Inclusiveness, Integrity and Local Representation. • The different, but not exclusive, families that voting systems fall into are; First Pass the Post, Alternative Vote, List of Proportional Representation, Mixed Member Proportional, Single Transferable Vote, Compulsory Voting, Electronic (Online) Voting.

Which alternatives to the current system were discussed? Did participants identify specific features that are important to them in an electoral system (for example local representation, proportionality, simplicity, legitimacy etc.)? (suggested limit: 500 words)

- Is Run Off Voting a possibility?
- Cast votes vs. Eligible votes?
- Some have voiced concern that the PM may have a preference for ranked ballots, which may eschew the final outcome of these consultations.
- Questions have been raised regarding the possibility of Individual candidates
- Concerns have been voiced on whether the public alone can be entrusted to change our system.
- Alternative systems of voting (presented here) are complex
- Mixed support of the 5 families which voting systems tend to fall into
- Voting systems are complex, need education on it
- A majority of participants recommended to have to keep the system simple. Our current system, although problematic, is simple and understandable.
- Some have argued that the public needs to be more educated on our electoral system.

Did participants discuss why they feel many Canadians choose not to engage in the democratic process? Did they suggest ways to encourage participation? (suggested limit: 500 words)

- Apathy, lack of information, faith, trust, honesty, transparency, voices not heard, undemocratic, votes don't count.
- Need to get more people to vote.
- Some have argued that political awareness needs to start at an early age. However, participants were divided on whether the voting age should be lowered to 16 years. Their main argument is that they may not necessarily know or understand the issues as they should. However, in raising political education in highschool, those that chose not to continue to pursue higher education will still be have a solid basis that could guide their voting choice, but the time they become eligible to vote.

Did participants feel that it should it be mandatory to cast a ballot? (Can include spoiling a ballot.) (suggested limit: 500 words)

- Mandatory voting was regarded as generally a good idea. However, many did not appreciate that there could be a penalty if they do not vote, some have cited accessibility problems as making it difficult to vote, and as such it would be unfair to receive a penalty.
- Some have mentioned that although mandatory voting may increase voter turnout, it will not necessarily guarantee that individuals make informed choices. More education was cited as a better alternative.
- Comments were made the mandatory voting was too dictatorial, although the right intention was at heart, the approach was not.

Did participants discuss online voting? Did they express a desire to maintain current voting practices? (i.e. presenting themselves at a polling station, vote secrecy etc.) (suggested limit: 500 words)

There was consensus that online voting was a desirable option, that in some cases it will be the wave of the future and it is inevitable that our system will have an online integration into it. However, the government was urged to ensure that it is secure, and that private information was protected.
