The Way Forward

To guide the action of APEC members participating the Healthy Women, Healthy Economies initiative, a Policy Toolkit was developed by its participants, with a focus on five areas:

- 1. Workplace Health and Safety
- 2. Health Access and Awareness
- 3. Gender-based Violence
- 4. Sexual and Reproductive Health
- 5. Work/Life Balance

The objective of the Toolkit is to present this information in a user-friendly way, providing a menu of options that national economies may draw from to pilot, implement and scale up on a voluntary basis in order to have the greatest impact in improving economic opportunities for women.

We believe the HWHE initiative is well-aligned with the Canadian government's gender equity agenda, from designing a more generous and flexible caregiver and parental leave policy, to ongoing development aid for maternal sexual and reproductive health.

Our hope is that Canadian policymakers can benefit from the best practices shared through HWHE to close gender gaps in areas such as workplace health and safety and health access and awareness. Just as pressing, however, is the need for Canadian leadership within the HWHE initiative, to share Canada's successes with APEC members so that the global economy as a whole can benefit.



Recommendations

The Healthy Women, Healthy Economies initiative aims to reduce the health barriers to women's full economic participation by affecting policy change. We invite Canada to help shape and influence this change, by raising its voice on the global stage and demonstrating how gender equality can benefit the global economy.

Canada can contribute to Healthy Women, Healthy Economies by:

- Taking a leadership role within the HWHE initiative by sharing Canadian gender equality best practices with APEC members
- Helping to "Canadianize" the HWHE Policy Toolkit by identifying areas where action is needed to benefit Canadian women and the Canadian economy
- Participate in the collection of gender-specific data to help measure the impact of gender equity initiatives across APEC countries

The goal of Healthy Women, Healthy Economies is to strengthen the capacity of women globally in the workforce and to accelerate progress toward global gender parity. Help us enable more women to live healthier lives, so that they can achieve their full economic potential.
