

My mother moved from Edmonton to Chilliwack in 2016 so she could be closer to me - her daughter - I cared and loved her. I am my mother's only daughter who moved my mother in 2016 to Chilliwack from Edmonton along with my brother Vern the truck driver. She gave up an Alberta pension to be closer to me. I also moved from Burnaby to Chilliwack to be closer to my mom. In May I drove my mom to Abbotsford hospital after she gagged on a vitamin on an empty stomach. I avoided Chilliwack hospital at all costs after all the townspeople of Chilliwack warned me, "don't ever go to Chilliwack hospital - Unless you want to die!" My mom had already had a cat scan done at Chilliwack hospital prior in May because all of a sudden she couldn't speak. The doctors suspected cancerous brain tumour but that was not a worry to me because I already dealt with that with my husband who **had a terminal brain tumor in the same location but we counteracted it with our alternative concoction of herbs.** My mother bought the herbs that work specifically on cancer and plus our church prayer team was praying. To make a long story short my husband is fine today, cancer free.

After my mom gagging on a vitamin I drove her to Abbotsford hospital avoiding Chilliwack and the neurosurgeon talked my mom into going through with the brain surgery to extend her life and my daughter was the witness. They transferred my mother to Royal Columbian Hospital from Abbotsford to perform the surgery. Immediately, we noticed the change in efficiency -- there was a difference in professionalism by several nurses towards my mother at Royal Columbian compared to Abbotsford. Not good. My mother - I had realized after dealing with my daughter at Children's Hospital for five months along with my mother who also had an eating disorder. The medical doctor completely ignored it. There are many nurses ignoring older people - I witnessed FIRSTHAND with my two daughters the discrimination. I went out of my way everyday to go down and make sure my mom was eating because she was not in her right mind because of the eating disorder and the tumour was pressing on her brain she was not able to speak.

Two nurses at Royal Columbian Hospital ignored me and my mother when I brought it to their attention that my mom was bleeding mysteriously from the bum just like the other man on intheinname.ca. who also spent time in Royal Columbian Hospital. I brought my mom to the bathroom and noticed all this blood in her diaper? I was appalled at the nurses attitude? I thought to myself, "what is going on here,?" Something here is not right? The one nurse of East Indian descent snarled, "she's got cancer and walked away while the other nurse; an older caucasian nurse with dyed blonde hair - replied, not making eye contact," she's got hemorrhoids!" I was sick to my stomach at their behaviour. Grown woman in a position of taking care of people acting like this.

Anyways, they ignored her bleeding and of course that led to my mother needing a blood transfusion. That is the only paper I ever officially signed (blood transfusion) for my mom except for her death certificate.

When my mother went into surgery my daughter Karen and I stayed up all night praying for her life - but got interrupted by a rude phone call by a nurse/social worker excitedly happy she had a heart attack. This person who called herself a social worker not older than my daughter blatantly out loud announces in front of my mother's hearing! Arrogantly guarantees, "My mother will not make it out of here!" I want her licence revoked! Royal Columbian Hospital starved my mother

for over a week and she when she was already in an anorexic state! I spent 5 months in Children's hospital with the Anorexics. My mother was an anorexic living with me. Someone else came up to me after I voiced my concerns about my mom not receiving food and she acted condescending to me,"saying at me like I'm dumb," people live a long time with no food. I was appalled at her medical opinion! Wrong - that is not what I was taught at Children's Hospital after five months of instruction. Liars with an intent of killing widows. I was told human bodies that are starved can have heart attacks and their organs will shut down.

After praying - my mother makes it out of intensive care and into the overflow room of Royal Columbian Hospital that has no windows. People dying left right and center. One time I went to visit my mom and she passed out. I asked the nurse on hand, what is wrong with her, " the nurse acts all fidgety? My mother is completely slumped over. "No more drugs!" I said! My mother who was starting to speak again asked my brother Vern repeatedly when he visited that she wanted to come home. I just thought to myself when she gets the proper nutrients to build strength. She was so malnourished it was like the WW NAZI Camps. In the overflow room at Royal Columbian Hospital the staff started setting my mom up in her chair each day - wonderful. Plus, finally the Royal Columbian Staff relented to a tube feed. The tube feed was supplying my mom with vital nutrients with amazing results. But then I find out she is being transferred. I requested Abbotsford - The So called arrogant name tag that says **Brian** who was avoiding me says my mother is being transferred to Chilliwack hospital- I was about to throw up when I heard this after all the warnings. He said offhandedly, "just get a transfer when she gets there." Traveling all the way to Chilliwack was such a financial burden and so out of the way. Over and hour each way not including the gas horrible let alone tiring.

I received a phone call in the car while driving my car - I should never have answered from Dr Gordan.ENNs who would not get off the phone until I accepted DNR. I had no idea what that meant. Dr. Enns laughed over the phone mockingly in my ear, saying he read my mom's report. (he was going on vacation in a couple of days} He said,"you don't want her ribs broken do you?" My daughters are both witnesses to how he would not get off the phone even though I told him," I'm driving?" I agreed to get him off the friggin phone . I didn't want to be charged with driving while holding my cell phone.

Chilliwack hospital started their program of euthanizing my mom as soon as she arrived.By cutting her tube feed and lying saying she couldnt swallow. A barium swallow was never performed. . They did not tell me what they were doing. They didn't adhere to any of Canada's Euthanasia protocol and ignored all my mother's requests as well as mine. We never consented to euthanasia EVER! They took advantage of the vulnerable and overstepped their boundaries! They even tried to say I was of no known address.

I went every day with my daughter because I sensed something wrong in the air. Verbally, repeatedly, I said no drugs and my daughter did as well! "Only Tylenol if needed," we specified. **My mom was not in pain.** Punk resident doctor Ryan Gant (who hasn't even been a doctor for two years younger than my daughter) said," he will be the judge of that! and also said, I'm the doctor!" He also asked me if I had the power of attorney {which he said he wanted to see} and if I owned a house and what we did for an income and what my mother wanted. I said she wants to LIVE! I even came to the hospital with the pre advance papers written and filled out by my

mother. The teenage nurse at Chilliwack Hospital shoved them out of her way and said," these aren't legal papers!" Punk Ryan also made us watch with a church member as he inserted a tylenol into my mother's lifeless naked body. I said my mother wants to live! She went through brain surgery like my husband did at the age of 74 for nothing and made it through even though the medical staff pierced anus to make her bleed to have a blood transfusion then I have the nurses ignored and starve her. I witnessed how they never ever helped my mom to eat but instead - as soon as the food trays arrived the short haired older gray hair nurse quickly removed them! I KNEW WHAT THEY WERE DOING _ STARVING MY MOM! TOPPING IT UP WITH THEIR KILLING DRUGS!" I was not working at the time but I conjured up enough money together to get gas to make it to the hospital because I witnessed first hand the ignorance towards my mother because they thought she was not worthy to be alive because of her appearance that they thought she was older. I went everyday and brought her my own boost I bought. Because I knew deep in heart heart they were KILLING HER!

My mother was always attacked at night and I would receive weird phone calls in the morning that my mother had a rough night at the hands of medical staff at Chilliwack hospital and Royal Columbian Hospital.

My mother was enjoying the Walmart dvd I brought- my daughter Katrina made her a prayer dvd to watch and listen to with headphones we bought for her. There is absolutely nothing for patients to do and the nurses stood around a table laughing talking among themselves. Citizens better start recording or hiring a security guard when going into B.C hospitals. Remember - everything they say and do is to advance their plan to eradicate the aged. I was traveling everyday out of my way to be there for my mom. The medical staff completely ignored her. Sickening.

When my mom was transferred I went immediately to visit my mom and I noticed on her chart it says"comfort car!?.My mom - was left in a corner off on her own unattended with a curtain drawn so nobody could see her in the hall. Unbelievable -plus Dr. Enns calls me again pressuring me, " you don't want your mom poked and prodded, do you? He is such an expert at this - killing! Uhmm? - "“ after all that blood work it will leave black and blue!"Yep ! You know what you are doing Dr, Enns. I had no idea what that would mean and didnt want my mom hurt anymore. **It was Dr. GORDAN Enns sinister plan to kill my mom.I could tell by his behaviour** he has done these pressure tactics before. The whole time I adamantly specified no drugs. My mom was not in pain - I was visiting everyday and could see through their lies. My mother can swallow - **I was feeding her THICK pea soup**. They lied and said she couldn't swallow!!!. I noticed the tube feed was not on and I asked the nurse and she said it's clogged. I said unclog it. I knew this was urgent for my mom also when one nurse upped the amount on the tube feed another nurse came along and turned it down. But right now this bunch of wicked nurses would not re hook the tube feed. They refused to saying my mom didn't want it because they were roughly putting it in through her nose. Of course she is going to react with her hands. Its only natural if it hurts. Then that was it for the tube feed then they said she couldn't swallow.I knew immediately in my heart they were trying to starve her. I started stuffing my purse with - boost, yogurt and I made sure I packed a spoon and a straw. Ducking down like I was smuggling drugs - **I fed my mother. She had no problem swallowing. It all was all a lie. When my parking ran out**

after two hours at the meter I didn't want to leave but I had to move my car so I positioned my purse so it would look like I'm just going to the bathroom! Then I ran for dear life! When I got back there was about 5 nurses surrounding my mom. Injecting her! The whole time not revealing what they are doing.

In between me visiting everyday to feed my mom and traveling all the way from Cloverdale I was asked to work . My daughter said she would stand guard and tell the nurses **NO DRUGS**. So I went to work and my daughter facetimes my mom to me while at work. After I got off the phone my mother asked my daughter to go outside like I had a couple days ago brought my mom outside on the patio - my daughter relayed the message to Nurse Anne who said she was a Christian. Ignored. My mother asked- she asked two times to go outside and again my daughter told nurse Anne my mom wanted to go outside. Even though my mother stated she wanted to go outside two times Nurse Anne ignored her requests and injected my mother with drugs killing her. She was given no food or drink in all this time except what I personally gave her. Chilliwack Staff their attacks with drugs even after I vocally told punk doctor Ryan Gant who just got out of med school younger than my daughter < "No DRUGS," shouting at me, He's the doctor and he'll be the judge!" My mom was not in pain - she was starved and needed food. More starvation and overdose of drugs. My mother was so thirsty and sucked on a sponge!!! These people must be charged with murder! SHE WAS MURDERED! I went to work for two days and that was it she is convulsing in my hands from euthanasia drugs. I placed two complaints to Fraser Health registering my mom's death with the Coroner- **the Coroner said," pursue this."** They murdered my mother and never followed any of the Canada Euthanasia guidelines. I complained twice to Fraser Health. Finally, Fraser Health said my mother was not a candidate for euthanasia. I already knew that! My mother lay in the morgue for three months. When the head of Chilliwack Hospital admitted to euthanizing my mother. I demanded an autopsy because I knew the evidence of what they injected her with was in her body. (we recorded the doctor) I had her cremated after the admission because I didn't have any money for a burial. We have her admission on tape. Fraser Health was phoning me everyday saying she's not in a freezer - she is in a cooler - which is probably a lie too. Then they tried to say a family member didn't want her to have an autopsy. I phoned my brother and he said he never said that. Chilliwack hospital murdered my mother and killed a Mentally Challenged man a couple weeks later which made it to CTV news but my mother's ordeal didn't make it to the news. Even though I contacted everyone!! put two complaints to Fraser Health who finally responded pronouncing - **NO MY MOTHER WAS NOT A CANDIDATE FOR EUTHANSIA**. Okay- now where is the justice? This is an injustice and a violation of our Canadian Charter of Rights and Beliefs and an attack on the most vulnerable in society!

This is Homicide and everyday I wake up and grieve because I brought my mom to a B.C hospital which led to her death. She should have lived! B.Cs medical system starved and drugged her to death! Homicide- then right after her a mentally challenged man who made it to CTV news 61. My mom was ignored - I contacted every politician, Crown Council and the

Coroner and the Coroner said, “pursue this .” I contacted various lawyers and one lawyer told me because my mom is 74 that is why no lawyer will take the case and told me about inthiername.ca I must mention the man in the next bed that I knew was next. Robert who had a touch of dementia and no one visited him in the whole time I was there. Chilliwack hospital was killing him.
