

I am Jawlan shirmemmet(Chinese ID call: Jiawulan Xiermaiti). I was born and grew up in suydung town, qorghas county of Eli Kazakh prefecture of Xinjiang Uyghur Autonomy region.I came to Turkey to study in 2011-12-20. I got enrolled in Istanbul ticaret University faculty of law in September 2012. I graduate in June 2018.Last time I came Turkey in 13 October 2016,Then I've never been to my homeland because of The CCP racist policy. Now , I'm living in İstanbul, and do some business.

My mother's name is Süriye Tursun (Chinese ID call:Suliye Tuerxun) . she is 56 years old and she is civil servant. She was an employee of management office of trade-industry in Qorghas county.She was an Accountant.At present she is being detained in Chinese concentration camps because I'm study in Turkey ,and my mother came to Turkey as a tourist with Chinese tour group to visited me and my school.

I have lost in touch with her in January 2018. All of my family members had deleted me from their wechat during that time. For worrying that my contact with them might bring them trouble, I did not dare to contact them.

But recents news passed to me made my life upside down. I was told that all of my family members were taken to the camps in 2018. The main reason of their detainment was my studying in Turkey and my Mother's travel to Turkey.and In 2019 December my father Shirmehmet Xudayar(Chinese ID: Xiermaiti Hudaya) and my brother Irfan Shirmehmet(Chinese ID: Ailifan Xiermaiti)were released,my father was gravely illled.and my mom was sentenced to five years jail because of she came to Turkey to visited me.

I want to ask Chinese authourity,If visiting Turkey were considered crime, why would China persecute millions of Han People who come to Turkey on a daily basis? Does not China's constitution guarantee "equality among all ethnic groups"? Why would only Turkic Muslim face this type of cruel treatment?

Upon hearing this calamity, I contacted Chinese consulate in Istanbul. Although they replied that they would get back to me, they have not kept their promise I. When I wrote to Chinese ministry of

foreign affairs, only response I got from them was a dead silence. It is not clear to me if Chinese government is silent because they are afraid of their crime or they are so arrogant that I can not do anything toward their crime?

After two month, The diplomat of the Chinese consulate called me and threatened me .Told me that my father and brother refused to talk to me ,Because they think I had connection with some anti-China organizations when I was in Egypt. but I never been to Egypt,The chinese government still lying,they don't want to me contact with my family.and they said if admit who i have contacted,which organization I have contacted,then maybe i can help my mom.then they will help me contact with my family.

In 01 Jun 2020,the Chinese authourity by forcing my father to call me, they're trying to warn me to be quiet.but i wont be quiet,until save my mother,until my mother get free, until i contact with my family as usual.

I beg the country in the world,UN, international human right organization help me to save my mother,free my mother, help me to contact with my family as usual.

## Suriye Tursun

### *Who is she?*

- Suriye Tursun (苏力也.吐尔逊) is a 56 years old Uyghur accountant works at Administration for Industry and Commerce in Qorgas county, China. She was near her retirement before she was taken by the Chinese government.
- Mother of two sons (Jevlan Shirmemmet, Irfan Shirmemmet) and the wife of Shirmemmet Hudayar. She is an educated college graduate who had successful career.
- Suriye Tursun's older son Jevlan Shirmemmet lives in İstanbul, Turkey. He graduated from Istanbul Commerce University majored in Law. Her younger son Irfan Shirmemmet (Ailifan Xiermaimaiti) graduated from Northwestern University, China in 2015. He was also taken to the notorious Nazi style Chinese internment camps in 2018, was released on the Second half of 2019
- Her Husband Shirmemmet Hudayar(Xiermaimaiti Hudayaer) was an official at the environmental protection office of Qorghas county. Now he is resting at home due to illness. He was very healthy man prior to his detainment but came out gravely ill he was released from the camp.

### *Current Situation*

- Suriye Tursun has been detained in Chinese concentration camps since 2018. Later Jevlan found out that she was sentenced to five years jail because she travelled to Turkey as a tourist with Chinese tour group to visit her son Jevlan and his school. Her current location still unknown.

### *Response to Suriye Tursun's case*

- Amnesty International Turkey office was contacted
- Her case was submitted to WGEID OHCHR
