Cannabis to Consumer, Bill C-45 Amendment of clause 37 PART 1 DIVISION 2

SUBDIVISION D, Section 36-40

To: Health of Commons – Standing Committee on Health From: Vend Data Media Soultions (VDMS Canada Inc.)

• Clause 37 – Unless authorized under this Act, it is prohibited to sell or distribute cannabis or a cannabis accessory by means of a dispensing device.

Our organization believes that our systems should be authorized under this act. Our "Smart Dispensing Systems" provide the following security and safety features below:

- Security
- Safety (Public and Employee)
- Point of Sale Automation
- Inventory Management
- Quality Control
- Point of Sale education, product knowledge and information
- Digital Media integration for public safety awareness & PSA
- Age verification and control measures

Our company sells a patented, fully secured, staff controlled automated dispensing system. We currently are providing this solution for the Convenience Store Industry, to help protect, secure and monitor their tobacco sales and inventory.

Our patented systems are particularly suited for the Cannabis industry in a retail setting. They provide security, control and real-time insight to all products sold in the store. Product is stored and locked in the machine at all times, allowing retail management to select appointed persons to be given access. The equipment is operated by staff/employees in the store, using our point of sale platform, and we can integrate with other POS providers as well. Our point of sale touch screen, can provide product knowledge to staff members so that they can make informed decisions about the products they are selling.

We believe that our systems will help protect public health and safety and allow Cannabis to be sold in a secure and safe manner, while protecting employees and ensuring product is kept out of the hands of minors. Our systems ensure that approved and regulated products are being sold, which helps to eliminate black market supply by controlling the distribution and sale of Cannabis products to consumers.

The "Smart Dispensing Systems" that we provide, will solve the issues and concerns outlined in this document.



Purposes of the Cannabis Act (Bill C-45)

• Clause 37 – Unless authorized under this Act, it is prohibited to sell or distribute cannabis or a cannabis accessory by means of a dispensing device.

Our organization believes that the clause above is very broad in the sense of defining a dispensing device. Our company currently provides an employee/staff operated secured dispensing machine (patented) that allows employees/staff within a retail setting to select product from a POS. Once the product is selected on the touch screen, the product is then dispensed from the secured machine, either behind the counter, under-the-counter or in a back office. At no time can any customer or member of the public interact or use our machines to purchase cannabis products. The sale of all cannabis products must go through the employee/staff member working behind the counter, who have the ability to dispense that product to the customer once they have confirmed the customer is of age and has paid for the product.

For this reason and the information provided through out this document, you will notice that our systems are not a self-serve dispensing device. They are a secured, controlled and monitored smart retailing systems, which will solve many of the issues mentioned in the proposed act and described in the document below.

The purpose of this Act is to protect public health and public safety and, in particular, to the following:

- protect the health of young persons by restricting their access to cannabis;
 - Our systems are controlled and operated by employees and staff within the retail location, customers can only access their Cannabis by interacting with a staff member behind the counter. Once the product is requested, staff will request legal identification to ensure the customer is old enough to purchase Cannabis. Once that is confirmed the product is selected from our POS touch screen and the product is then dispensed from our equipment which is behind the counter, under the counter or located in a locked back room. This would ensure that young persons cannot purchase Cannabis, using the same approach when purchasing Alcohol or Tobacco.
- protect young persons and others from inducements to use cannabis;
 - Using our real-time digital media platform, governments can display relevant educational content about the harms and effects of Cannabis use, this messaging can be presented in a variety of formats and updated weekly, monthly etc. Having a digital media platform at the Point of Purchase would allow the government to convey their public service announcements to the consumers and promote their campaigns which do not promote the use of Cannabis products.
- provide for the licit production of cannabis to reduce illicit activities in relation to cannabis;
 - Liaison with all the Licensed producers to develop an automated re-ordering system. Ensure that all product stocked in the machines are pre-packaged products from LP's and monitor the inventory and sales of these products all in real time. Having a locked and secured dispensing system, you can control whom is stocking the inventory to prevent illicit activities and keep black market products out of the



retail setting. Our system can be integrated into LP's software and other POS (point of sale) providers. Develop a inventory scanning system to determine legal supply is being distributed and sold through the proper channels

- provide access to a quality-controlled supply of cannabis; and enhance public awareness of the health risks associated with cannabis use.
 - Using our secured and tracked dispensing systems, retail management and government can ensure that all product sold from the equipment is from a legal and licensed producer, approved by Health Canada. The product information on the POS safeguards Cannabis products, as each image/graphic on the touch screen is connected to that specific product in the machine and this information cannot be changed without approval from retail management. Product selected from the POS delivers the product selected and this cannot be altered in anyway without the support of VDMS and consent from the retailer. The POS (Point of Sale) interface can be used to provide public awareness to the public and retail staff about the health risks of Cannabis use. Informing staff of the THC/CBD levels and what effects each strain may have on a person's health. Public health announcements can be incorporated into the digital signage platform and displayed at the point of purchase
- Retailers must follow record-keeping requirements (e.g., demonstrate that all product is sourced from licensed producers; due diligence in avoiding sales to youth).
 - This can be achieved by integrating the VDMS Dispensing System with retail inventory management and Licensed Producer sales information. All sales history and data is available in real-time, online and access is granted to those who have permissions to access the encrypted data.
