### **Board of Internal Economy Disclosure: Posting of the *House Officers' Expenditures Report*, the *Members' Expenditures Report* and the *Public Registry of Designated Travellers***

Ottawa, Ontario – June 12, 2018

The Honourable Geoff Regan, Speaker of the House of Commons and Chair of the Board of Internal Economy, announced today that the [House Officers' Expenditures Report](#) for fiscal year 2017–2018, the [Members' Expenditures Report](#) for fiscal year 2017–2018 and the [Public Registry of Designated Travellers](#) as at March 31, 2018, are now available to the public on [ourcommons.ca](http://ourcommons.ca).

#### ***House Officers' Expenditures Report***

At its meeting of [June 8, 2017](#), the Board of Internal Economy approved the public disclosure of expenditures for House Officers and National Caucus Research Offices, effective April 1, 2017. The *House Officers' Expenditures Report* summarizes expenses incurred in the discharge of their parliamentary functions, divided into five categories: employees' salaries, service contracts, travel, hospitality, and office expenses.

#### ***Members' Expenditures Report***

The *Members' Expenditures Report* for fiscal year 2017–2018 outlines Members' expenditures processed between April 1, 2017 and March 31, 2018. It includes the *Detailed Travel Points Report*, which provides information on Members' and authorized travellers' trips for which travel points are used, as well as the *Detailed Hospitality Expenditures Report*, which provides information on Members' hospitality expenses processed during this period.

#### ***Public Registry of Designated Travellers***

The *Public Registry of Designated Travellers* indicates the names of Members' designated travellers as at March 31, 2018.



## Quick Facts

- For fiscal year 2017–2018, the *House Officers' Expenditures Report* includes expenses processed for House Officers and National Caucus Research Offices between April 1, 2017 and March 31, 2018.
- Starting in 2018–2019, the *House Officers' Expenditures Report* will be published on a quarterly basis and will include the detailed disclosure of travel and hospitality expenses.
- Members and House Officers are responsible for ensuring that all approved expenses are incurred in the discharge of their parliamentary functions.
- Expenditures incurred by Members and House Officers are subject to the [Members' By-law](#) and the [Members' Allowances and Services Manual](#).
