Good morning,

This is to acknowledge receipt of your email. We hereby reply as follows:

"Hong Kong affairs are entirely China's domestic affairs that allow no unwarranted comments from external forces.

Since June last year, some radical protesters have deliberately stirred up violent incidents in Hong Kong as wantonly beating, smashing, looting and arson. Those violent terrorist acts have severely disrupted Hong Kong's social order, trampled on the rule of law in Hong Kong and severely damaged its economy.

Faced with the grave situation in safeguarding national security in Hong Kong, the Central Government has both the power and the responsibility to promptly plug the loopholes and strengthen the weak links. The Law on Safeguarding National Security in the HKSAR is adopted and promulgated by the NPC Standing Committee of China to crack down on the handful of illegal and criminal behavior and activities endangering state security. It will provide stronger institutional and legal guarantees for safeguarding China's sovereignty, security and development interests, upholding Hong Kong's enduring prosperity and stability, and ensuring the steady and sustained implementation of "one country, two systems". It will also safeguard the legal rights of freedom enjoyed by Hong Kong people and will help protect the legitimate rights and interests of investors in Hong Kong from various countries, including Canada. After the implementation of the Law, 80 percent of Hong Kong people believe that Hong Kong is safer and more stable. And Hong Kong again ranks 1st in the Fraser Institute's annual Economic Freedom of the World report which has been released recently.

We urge the Canadian side to view the Law in a fair, objective manner, stop in any way interfering in China's internal affairs including Hong Kong affairs."
