I am writing to respond to the motion of the Committee on November 22, regarding the shortages of pediatric analgesics.

Specifically, on November 22, 2022, the Standing Committee on Health (HESA) adopted the following motion:

That for the next six months Health Canada table with the committee every 14 days the number of infant and children's analgesic units that arrived in Canada through exceptional importations that month; and, that this information be provided in both official languages, and the clerk post this information on the committee's website immediately.

Please find attached the Department's response to the order of the Committee. In keeping with the schedule outlined in the Motion, the next report is due to the Committee on December 27, 2022. Given that this day is a statutory holiday, the Department's next report will be provided on the following day, December 28, 2022. The normal reporting schedule will resume on January 10, 2023.

We are available, as always, to address the Committee's questions and concerns.

Children's Analgesics

As of December 13, 1,256,030 units of children's pain and fever medications were imported into Canada for hospitals, community pharmacies, and retail outlets. This is an additional 96,030 units imported during the period of November 30 and December 13.

This will continue to supplement the increased domestic production of Canadian supply, which remains at record levels.

Products listed below include both acetaminophen and ibuprofen containing products that Health Canada has authorized to be imported to alleviate the shortage. Three products have been added to the list since the last report.
