I am writing to respond to the motion of the Committee on November 22, regarding the shortages of pediatric analgesics.

Specifically, on November 22, 2022, the Standing Committee on Health (HESA) adopted the following motion:

That for the next six months Health Canada table with the committee every 14 days the number of infant and children's analgesic units that arrived in Canada through exceptional importations that month; and, that this information be provided in both official languages, and the clerk post this information on the committee's website immediately.

Please find attached the Department's response to the order of the Committee. This is the same report that you received on April 18, 2023, as no additional units were imported during the period of April 19 to May 2. The next report will be provided to the Committee on May 16, 2023.

Children's Analgesics

As of May 2, 4,402,310 units of children's pain and fever medications were imported into Canada for hospitals, community pharmacies, and retail outlets. No additional units have been imported since the last report on April 18.

Products listed below include both acetaminophen and ibuprofen containing products that Health Canada has authorized to be imported to alleviate the shortage.
