The purpose of amendment number 003 is to respond to vendors' questions.

Question 1:

The criterion for bidders to demonstrate minimum billable days (M2) in all 10 listed resource categories and billable days in excess of M2 (R1) is extremely restricting for bidders as it would be very difficult to have all those roles covered under a maximum of 5 contracts.

We are asking the Crown, provided we otherwise meet all the other criteria, to allow bidders to demonstrate billable days in 7 out of the 10 listed resource categories under M2 as well as R1.

Response 1:

Canada has considered your request. However, corporate mandatory criterion M.2 will remain unchanged.

Question 2:

With regards to the above mentioned solicitation, would the Crown extend the maximum number of contracts in corporate mandatory M.2 from five (5) to seven (7) within the same timeframe (as per item #2 and 3)? The requirement as it stands, is far too restrictive for companies on the PSAB and reduces the likelihood of PSPC receiving multiple bids.

Response 2:

Question 3:

Due to the extensive time and effort required to demonstrate thousands of billable days across ten (10) categories as well as mapping 50% of SOW tasks for multiple contracts, we respectfully request a 2-week extension to July 9th, allowing bidders adequate time to prepare compliant and fully substantiated proposals.

Response 3:

Canada appreciates the level of effort to respond to requests for proposal. However, given the urgency of this requirement, Canada will not grant a bid closing date extension at the moment.
